Logo Brief: Fiji ratified the Asia-Pacific Regional Convention on the Recognition of Qualifications in Higher Education (2011) (aka Tokyo Convention 2011) on Wednesday 19 February 2020. As a signatory of the regional convention, the main goal of Fiji's NIC is to be a one-stop-shop for higher education information in Fiji. The main purpose of the Tokyo Convention 2011 is the recognition of qualifications. And one of the main ways to achieve this at a global scale is through the establishment of a network of (E) National Information Centres. The PC Monitor signifies that the NIC is an electronic centre where all information regarding the Fijian Higher Education is available on all devices, as long as you have access to the internet. The NIC logo, in a ballpark says, "recognition of Fijian Qualifications (inside the monitor) globally (globe encasing)". The logo intends to encapsulate the work of the NIC - facilitate recognition of higher education qualifications for both advancing education and employment in another country which is a Party to the Tokyo Convention. The computer represents the medium through which local and international students can access information about higher education systems and qualifications in Fiji and other countries. The map of Fiji put in a noticeable position within the world makes it easier to recognise that this website is Fiji's official National Information Centre. The globe also represents networking with NICs in other Parties to the Tokyo Convention. The graduation hats (inside and on the top of the screen) establishes equivalence between qualifications at local and international levels. This promotes international mobility, a key function of NIC.

Fiji National Qualifications Framework


